Officers - Certain instructions issued

All the D.E.Os are informed that the post of Dy E.O. is governed by A.P.E.S.
Rules. Government vide G.O.Ms.No 505 Education, Dated:16.11.1998 issued the A.P.
Educational Service Rules considering the Unification Service Rules of Government and
Panchayathi Raj Teachers. The Hon'ble A.P.High Court struck down the said rules as
far as the posts are covered by the Presidential Order.

Subsequently Government issued A.P. School Education Service Rules vide
G.O.Ms.No.95 Education, Dated:25.07.2005. The Hon'ble High Court set aside those
rules also and the matter has been carried over to the Hon'ble Supreme Court of India
As such the unification of service rules is in dispute before the Apex Court.

Consequent to the orders of A.P. High Court, Government in the reference 1st
read above issued orders to make Full Additional Charge arrangements to the vacant
posts of Deputy Educational Officers by placing District Educational officers, Principal
DIET, Deputy Educational Officers and Gazetted Headmasters Grade-I, Assistant
Director pending final decision taken on the judgment of High Court.

Further Government in the reference 2nd read above issued orders and permitted
for placing HM.Gr.II / MEOs / Lecturers / DIET / Senior Lecturers of DIET in FAC to the
vacant posts of Deputy Educational Officer in the State for smooth functioning of the
administration.

In view of the above, all the DEOs are requested to make FAC arrangements to
the vacant post of Deputy Educational Officers in their district after obtaining approval of
District Collectors concerned keeping in view of the orders issued by Government in the
references 1st and 2nd read above and also taking into consideration the local
requirement and need in the district.
